#### Planning for 2020-21 School Year

- July 16: FUHSD announced that the year would begin in remote learning
- July 17: Governor Newsom issued guidance that prevents schools from opening for in-person instruction in August if they are located in CA counties that are currently on the State's COVID-19 watchlist
  - We've heard some questions from the community about the State Waiver at this time this is only for Elementary schools, not older students, Special Education programs or other groups of learners

#### Planning for 2020-21 School Year

- While we are grateful for this direction from the State, there are still many unanswered questions about when and how schools will begin to bring students and staff back to campuses safely
- District leadership continues to meet with the Santa Clara County Office of Education and Public Health twice a week as a county group, and our planning will continue to be guided by public health recommendations



We appreciate the efforts by our students, staff and families to work together during this extraordinary time. Everyone's commitment to the education of our students in spite of the impact of COVID-19 is nothing short of heroic. We are dedicated to continuing our partnership in this work.

#### **District Special Education Priorities**

- 1) Focusing on the health and safety of students, staff and the FUHSD community.

#### School Closure Impact to Individualized Education Plan (IEP) Services

Transition to Remote Learning

- All in person assessments halted
- IEP meetings moved to virtual platform
- Procedures for Specialized Academic Instruction (SAI) and related services move to virtual delivery
- Increased support for students and parents to access remote learning
- Targeted outreach for those families struggling in the transition
- Communication with non-public schools and Santa Clara County Office of Education

#### Distance Learning Plan

- FUHSD will provide special education and related services in a manner that ensures that your child's IEP can be executed in the distance learning environment.
- The execution of your child's IEP in a distance learning model may vary from the manner in which your child's IEP is implemented during in-person instruction at a school site.

#### Specialized Academic Instruction (SAI)

- Periods of instruction will follow the daily schedule
  - Each period will be 180 minutes weekly (225 during in person)
- Other SAI minutes will occur within the weekly schedule
- Schedule for students in post-secondary programs will include daily SAI

#### **Related Services**

- All services provided virtually
- Providers will make every effort to offer equivalent weekly/monthly minutes on the student's IEP

Individual Counseling Counseling & Guidance Speech and Language Occupational Therapy Adaptive Physical Education Behavior Services

#### Accommodations in General Education

- All teachers will be provided with the student's accommodation plans and needs.
- Teams will consider if adaptations are necessary in distance learning
- Special education staff will collaborate with general education teachers to support implementation and monitor progress.

#### IEP Meetings

- Individuals with Disabilities Education Act (IDEA) compliance has NOT been waived
- Meetings will be held in a timely manner and in compliance with the student's IEP due date
- Meetings will be held virtually
- Parents and team members can participate virtually or telephonically
- Signatures will be gathered electronically

#### Assessments

- Per Senate Bill 117 assessment timelines have been put on hold for those evaluations that require face to face interaction to be valid
- Triennial IEPs will complete a record review and other assessments deemed necessary that can be conducted remotely
- Other assessment measures will only be implemented once FUHSD has been provided approval to conduct in person activities
